PLAYER ELIGIBILITY REQUIREMENTS & REGISTRATION CHECKLIST

To be eligible to play football for the Johns Creek Jr. Gladiators and prior to **ANY** participation (in practices or games) each player and his parents/guardians **MUST** agree to or provide the items listed below to the Board of Directors. Note that all forms, payments, and deposit checks **MUST** be submitted at equipment pick-up before receiving any football equipment.

- 1. **Registration Form** – Complete all information.
- 2. **Medical Information Form** – Providing Doctor, Allergies and Medical treatment release.
- 3. **NGFL Waiver Form** - Must be signed and completed by Parent/Guardian. Form must be turned in at equipment pick-up, prior to receiving equipment. Player is ineligible to play if signed waiver is not on file.
- 4. **Signed Physical Form** - Signed Physician’s Statement, dated after 1/1/11.
- 5. **Copy of Birth Certificate** (kept on file) - **NEW** Junior Gladiator players only.
- 6. **Registration Fee** - The fee for playing is \$350.00. Payment by check (return with forms and other checks or pay the \$350 registration fee online and indicate above).
 Sibling Registration Fee - \$250 (Per child fee for second child or more from same family involved in Junior Gladiator Football program).
- 7. **Volunteer Deposit Check** of \$75.00
NOTE: the check **MUST** be submitted before equipment is issued. The check will be returned at the end of the season, if players family has met the minimum 10 hour volunteer service requirement.
- 8. **Equipment Deposit Check** of \$150.00 – This check will be returned at the end of the season if/when ALL issued equipment is returned on designated Equipment Return Day.

WITHDRAWAL FEES:

No refunds are issued if withdrawn after August 14th **OR** if verification from the Department of Education indicates that you are not in the Johns Creek School District and/or if you fail to provide documentation to support eligibility.

- By May 31st - \$100 withdrawal fee
- By August 13th - \$150 withdrawal fee

FULTON COUNTY ZERO TOLERANCE POLICY REGARDING FAN BEHAVIOR

Any negative cheering/yelling will result in a warning and/or removal from the site, whether it is for or against your team. Negative cheering shall be defined as cheering/yelling that is profane or derogatory in nature or cheering/yelling that is deemed, in the opinion of the Game Officials, Tournament/League Director or his/her Designee, to be an unnecessary disruption to the game. No artificial noisemakers will be allowed in the bleachers, seats or standing area around the perimeter of competition. Only Coaches, Players and Trainers will be allowed on the sidelines. Fans are to remain in the bleachers. Parents may come to the sidelines upon an injury only.

GRIEVANCE PROCEDURE

If a parent or member has a complaint, the first step is to discuss the problem with the appropriate Head Coach. If this does not satisfy the parent's complaint, a meeting with the head coach, the parents, and the president of the board shall be set. The president shall act as an arbitrator, if required and/or requested to do so. Should the offended party not be satisfied after this meeting, a formal complaint must be presented in writing to the board of directors. The president shall appoint a grievance committee of at least (3) Board Members and shall chair the grievance meeting. Said meeting must be conducted within fourteen (14) days after formal presentation of the complaint. No party to the grievance is permitted to be involved with the committee. The decision of the grievance committee may be appealed to the board of directors. The decision of the board on appeal shall be final. Playing time or a coach's decision on who plays and where they play is not grounds for a grievance procedure.
